Kenneth Youngblood moved that SCHG donate \$200.00 to St Jude's Children's Hospital, Memphis, TN. Dan Mitchell seconded. Motion approved by a vote of seven "ayes" and one "no".

All members present agreed that the remaining \$800.00 allocated to charities would be distributed at a later date.

Kenneth Youngblood moved that SCHG approve the expenditure of \$500.00 from the General Fund for the purchase of advertising for the purpose attracting new members to our organization. John Williams seconded. Motion carried by unanimous vote.
