# Stephens County Honor Guard Special Business Meeting Minutes - March 30, 2023

Minutes of the business meeting held January 19, 2023, were presented. Kenneth Youngblood moved that the minutes be accepted as presented. Paul Frable seconded. Motion carried by unanimous vote.

Treasurers Report for months of January 2023, February 2023 and March 2023 were accepted as presented.

## New Members:

Guests Coral D Porch and Michael Paradiso applied for membership. Elected officers of SCHG reviewed DD-214 forms submitted by each applicant and verified they met the membership eligibility requirements. Both applications were accepted by unanimous votes.

## Officer's Reports:

Commander - Commander McAdory thanked members for their support of the SCHG's activities to honor deceased veterans. A total of thirty-three services were conducted during January, February and March.

## Old Business:

Kenneth Youngblood moved that the door to the room used by SCHG at the armory be rekeyed and five new keys be obtained and issued to appropriate persons. Dan Mitchel seconded. Motion carrier by unanimous vote.

## New Business:

Paul Frable proposes SCHG examine the possibility of obtaining warmer gloves and overcoats and/or other outer garments for use in frigid weather. Kenneth Youngblood recommends that action on this be postponed to a future meeting and suggests that members provide gloves and other articles of clothing for examination.

Roy Grabman moved that member Rick Duncan to the status of Honorary Life Member. Dan Mitchel seconded. Motion carried by unanimous vote.

Planning for Memorial Day observances is underway. Commander McAvoy has contacted several guest speakers including Rep. Marcus McEntire, and Senators Garvin and Kidd.
